


NOTICE OF MEETING

FORT BEND COUNTY MUNICIPAL UTILITY DISTRICT NO. 128

The Board of Directors of Fort Bend County Municipal Utility District No. 128 will hold a regular meeting on **Monday, October 24, 2016, at 8:30 a.m.**, at The Muller Law Group, PLLC, 16555 Southwest Freeway, Suite 200, Sugar Land, Texas, to discuss and, if appropriate, act upon the following:

 - d. approve pay estimates, change orders, and acceptance of projects as appropriate, for construction of the following:
 - i. Avalon, Section 12A;
 - ii. Avalon, Section 12B;
 - iii. Avalon, Section 20;
 - iv. Avalon, Section 24A;
 - v. Cabrera Drive;
 - vi. Lift Station No. 7; and
 - vii. Noble Seven;
 - e. deeds, easements, or consents to encroachment;
 - f. update on bond application; and
 - g. miscellaneous engineering items.
9. Update on GIS mapping of District property.
10. Development in the District, including:
 - a. approve or amend Development Financing Agreement; and
 - b. reimbursement matters.

11. Discuss Stormwater Management Plan, receive comments from the public, and conduct training as necessary.
12. Discuss District website.
