


NOTICE OF MEETING

FORT BEND COUNTY MUNICIPAL UTILITY DISTRICT NO. 128

The Board of Directors of Fort Bend County Municipal Utility District No. 128 will hold a regular meeting on **Monday, April 24, 2017, at 8:30 a.m.**, at The Muller Law Group, PLLC, 16555 Southwest Freeway, Suite 200, Sugar Land, Texas, to discuss and, if appropriate, act upon the following:

1. Public comments.

6. Financial and bookkeeping matters, including payment of the bills and review of investments.

 - c. review bids, award contracts, and approve letter financing agreements and cost sharing agreements for projects in the District, including:

 - ii. Avalon, Section 17;
 - iii. Avalon, Section 24B;
 - d. approve pay estimates, change orders, and acceptance of projects as appropriate, for construction of the following:
 - i. Avalon, Section 12A;
 - ii. Avalon, Section 12B;
 - iii. Avalon, Section 18B;
 - iv. Cabrera Drive between University Boulevard and LJ Parkway;
 - v. Sanitary Sewer Extension along LJ Parkway and Cabrera Drive;
 - vi. Sanitary Sewer Improvements for Avalon at Riverstone, Section 17; and
 - vii. 8" Water Line & 10" Sanitary Sewer Line to serve the Village at Riverstone.
 - e. Cost Sharing Agreement with Fort Bend County Levee Improvement District No. 15 for Cabera Drive;
 - f. deeds, easements, or consents to encroachment;
 - g. GIS mapping;
 - h. Master Service Agreement for geotechnical services; and
 - i. miscellaneous engineering items.
9. Development in the District.

10. Stormwater Management Plan, including public comments and training.
