
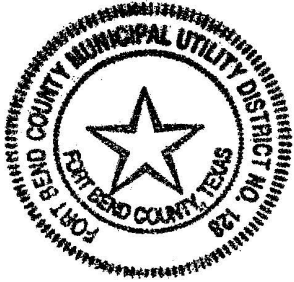


NOTICE OF MEETING

FORT BEND COUNTY MUNICIPAL UTILITY DISTRICT NO. 128

The Board of Directors of Fort Bend County Municipal Utility District No. 128 will hold a regular meeting on **Monday, October 22, 2018, at 8:15 a.m.**, at **The Muller Law Group, PLLC, 202 Century Square Boulevard, Sugar Land, Texas**, to discuss and, if appropriate, act upon the following:

 - a. appointment of Paying Agent/Registrar;

 - b. hearing on termination of water and sewer service to delinquent customers and authorize termination of service.

10. Engineering matters, including:
 - a. authorization for design of Avalon, Section 19;
 - b. approval of plans and specifications and authorize for competitive bids or proposals;
 - c. approval of contracts, letter financing agreements, or cost sharing agreements, including:
 - i. 8" sanitary sewer extension to service Arista Riverstone Active Adult Community.
 - d. approval of pay estimates, change orders, and final acceptance, including:
 - i. 8" Water Line & 10" Sanitary Sewer Line to serve the Village at Riverstone; and
 - ii. Avalon, Section 14.
 - e. deeds, easements, utility conveyances, and consents to encroachment; and
 - f. miscellaneous engineering items.
11. Development in the District.
12. Stormwater Quality Management Plan, including:
 - a. Year 4 annual Stormwater management plan report;
 - b. Resolution Adopting Stormwater Guidance Manual and Penalties for Violation;
 - c. public comments and training; and
 - b. amended and restated Rate Order.
13. Future meeting dates and agenda items.
