
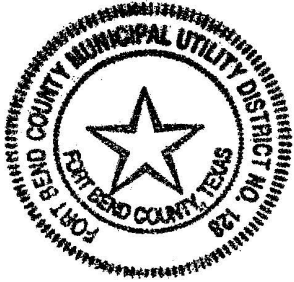


## NOTICE OF MEETING

### FORT BEND COUNTY MUNICIPAL UTILITY DISTRICT NO. 128

The Board of Directors of Fort Bend County Municipal Utility District No. 128 will hold a regular meeting on **Tuesday, November 27, 2018, at 12:00 p.m.**, at **The Muller Law Group, PLLC, 202 Century Square Boulevard, Sugar Land, Texas**, to discuss and, if appropriate, act upon the following:

1. Public comments.
2. Minutes.
3. Law enforcement matters.
4. City of Sugar Land matters, including fire protection fee CPI adjustment.
5. Series 2018 Unlimited Tax Bonds, including:
  - a. review of bids and award of sale of the District's \$11,450,000 Unlimited Tax Bonds, Series 2018;
  - b. Resolution Authorizing the Issuance of the District's \$11,450,000 Unlimited Tax Bonds, Series 2018;
  - c. Paying Agent/Registrar Agreement;
  - d. Official Statement;
  - e. execution of Amendment to Information Form; and
  - f. authorization to sign all documents relating to the bond sale and authorization for attorney and financial advisor to take all necessary action to deliver bonds to the purchaser.
6. Audit for fiscal year end July 31, 2018.
7. Financial and bookkeeping matters, including payment of the bills and review of investments.
8. Tax assessment and collections matters, including installment agreements and payment of tax bills.
9. Operation of District facilities, including:
  - a. billing, repairs, and maintenance; and
  - b. hearing on termination of water and sewer service to delinquent customers and authorize termination of service.
10. Engineering matters, including:
  - a. authorization for design of Avalon, Section 19;
  - b. approval of plans and specifications and authorize for competitive bids or proposals;
  - c. approval of contracts, letter financing agreements, or cost sharing agreements, including:
    - i. 8" sanitary sewer extension to service Arista Riverstone Active Adult Community.
  - d. approval of pay estimates, change orders, and final acceptance, including:
    - i. 8" Water Line & 10" Sanitary Sewer Line to serve the Village at Riverstone; and
    - ii. Avalon, Section 14.
  - e. deeds, easements, utility conveyances, and consents to encroachment; and
  - f. miscellaneous engineering items.
11. Development in the District.
12. Stormwater Quality Management Plan, including public comments and training.
13. December meeting date.
