
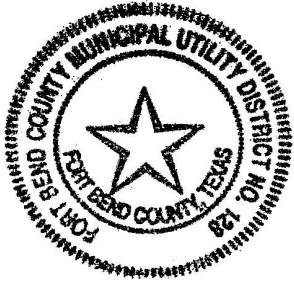


## NOTICE OF MEETING

### FORT BEND COUNTY MUNICIPAL UTILITY DISTRICT NO. 128

The Board of Directors of Fort Bend County Municipal Utility District No. 128 will hold a regular meeting on **Monday, January 28, 2019, at 8:15 a.m.**, at **The Muller Law Group, PLLC, 202 Century Square Boulevard, Sugar Land, Texas**, to discuss and, if appropriate, act upon the following:

1. Public comments.
2. Minutes.

5. Annual Report and filing in accordance with the District's Continuing Disclosure of Information Agreement and as required by SEC Rule 15c2-12.
6. Financial and bookkeeping matters, including payment of the bills and review of investments.

8. Garbage collection report, including annual CPI adjustment.
9. Operation of District facilities, including:
  - a. billing, repairs, and maintenance; and
  - b. hearing on termination of water and sewer service to delinquent customers and authorize termination of service.

  - a. authorization for design of District facilities;
  - b. approval of plans and specifications and authorize for competitive bids or proposals;
  - c. approval of contracts, letter financing agreements, or cost sharing agreements, including:
    - i. 8" sanitary sewer extension to service Arista Riverstone Active Adult Community; and
    - ii. Avalon, Section 19.
  - d. approval of pay estimates, change orders, and final acceptance, including Avalon, Section 14.
  - e. deeds, easements, utility conveyances, and consents to encroachment; and
  - f. miscellaneous engineering items.

12. Amendment to Development Financing Agreement with Winding Waters, Ltd.
13. Stormwater Quality Management Plan, including:
  - a. Year 5 annual Stormwater management plan report; and
  - b. public comments and training.
