
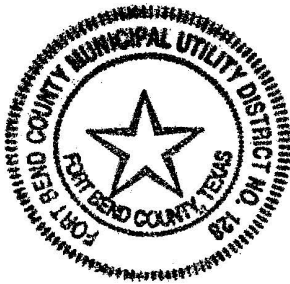


NOTICE OF MEETING

10. Order Adopting Amended and Restated Water Conservation Plan.
11. Engineering matters, including:
 - a. authorization for design of District facilities;
 - b. approval of plans and specifications and authorize for competitive bids or proposals;
 - c. approval of contracts, letter financing agreements, or cost sharing agreements, including:
 - i. 8" sanitary sewer extension to service Arista Riverstone Active Adult Community; and
 - ii. Avalon, Section 19.
 - d. approval of pay estimates, change orders, and final acceptance, including Avalon, Section 14.
 - e. deeds, easements, utility conveyances, and consents to encroachment;
 - f. update on bond application no. 8; and
 - g. miscellaneous engineering items.

13. Stormwater Quality Management Plan, including public comments and training.
