
## NOTICE OF MEETING

  - d. approval of pay estimates, change orders, and final acceptance, including Avalon, Section
  - e. deeds, easements, utility conveyances, and consents to encroachment;
  - f. update on bond application no. 8, including Resolution Authorizing Resolution Application to the Texas Commission on Environmental Quality for Approval of Projects and Bonds; and
  - g. miscellaneous engineering items.
