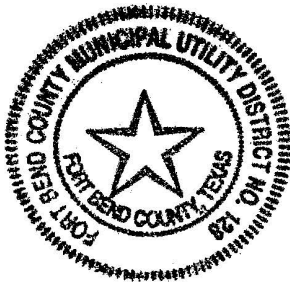



NOTICE OF MEETING

 - d. approval of pay estimates, change orders, and final acceptance, including Avalon, Section 19.
 - e. deeds, easements, utility conveyances, and consents to encroachment;
 - f. update on bond application no. 8, including Resolution Authorizing Resolution Application to the Texas Commission on Environmental Quality for Approval of Projects and Bonds; and
 - g. miscellaneous engineering items.

12. Stormwater Quality Management Plan, including public comments and training.
