
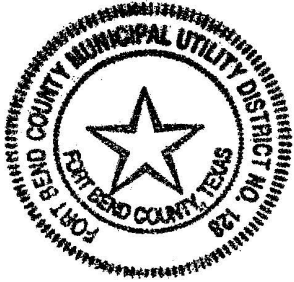


## NOTICE OF MEETING

### FORT BEND COUNTY MUNICIPAL UTILITY DISTRICT NO. 128

The Board of Directors of Fort Bend County Municipal Utility District No. 128 will hold a regular meeting on **Monday, June 24, 2019, at 8:15 a.m.**, at **The Muller Law Group, PLLC, 202 Century Square Boulevard, Sugar Land, Texas**, to discuss and, if appropriate, act upon the following:

1. Public comments.
2. Minutes.
3. Law enforcement matters.
4. City of Sugar Land matters, including proposed amendment to Strategic Partnership Agreement.
5. Renewal of District insurance policies.
6. Financial and bookkeeping matters, including:
  - a. payment of the bills and review of investments; and
  - b. draft budget for fiscal year ending July 31, 2019.
7. Tax assessment and collections matters, including:
  - a. installment agreements and payment of tax bills; and
  - b. authorize delinquent tax attorney to proceed with collection of delinquent taxes.
8. Adoption of Resolution Nominating Candidate for Board of Directors Election for Fort Bend Central Appraisal District.
9. Operation of District facilities, including:
  - a. billing, repairs, and maintenance; and
  - b. hearing on termination of water and sewer service to delinquent customers and authorize termination of service.
10. Engineering matters, including:
  - a. authorization for design of District facilities;
  - b. approval of plans and specifications and authorize for competitive bids or proposals;
  - c. approval of contracts, letter financing agreements, or cost sharing agreements;
  - d. approval of pay estimates, change orders, and final acceptance, including
    - i. Avalon, Section 19; and
    - ii. 8” sanitary sewer extension to service Arista Riverstone Active Adult Community.
  - e. deeds, easements, utility conveyances, and consents to encroachment;
  - f. bond application no. 8; and
  - g. miscellaneous engineering items.
11. Bond anticipation note, including:
  - a. Placement Agent Agreement;
  - b. Fee Letter Agreement; and
  - c. authorization for developer reimbursement report.
12. Development in the District.
13. Stormwater Quality Management Plan, including public comments and training.
14. Director appointment matters, including:
  - a. approve Sworn Statement, Official Bond, and Oath of Office of new directors;
  - b. Open Meetings Act training requirements;
  - c. conflict of interest disclosure requirements under Chapter 176 of the Texas Local Government Code, including review of disclosure forms adopted by the Texas Ethics Commission; and
  - d. reorganize the Board and authorize execution of District Registration Form.
